City Wide Clean-Up

PSI will have dumpsters available at City Hall, (in parking lot by the old Ag building) and at the Lewiston Well. These will be available from November 12th to the 15th. These are for Wendell Citizens to use for yard cleanup waste, etc.

PLEASE, NO APPLIANCES or TIRES, take those to the transfer station North of Wendell. Do not set stuff next to the dumpster, put all your waste and trash **IN** the dumpster.

2016 Dog licenses are now available at City Hall.

Dog licenses are to be renewed annually by the end of January each year.

Licenses are \$5.00 each for a neutered male or a spayed female. Not neutered or spayed then the fee is \$10.00 each.

Please bring in proof of rabies shots and information on microchips if the dog has been chipped. On February first there is a late fee of \$5.00 added to the cost of the license. Wendell City Council is currently reviewing the costs of dog licensing and impound fees. Now is the time to renew your dogs licenses as fees could go up depending on the Council's decisions. City ordinances do not allow for licensing kennels in the city limits and restricts dog ownership to three dogs per household.

2016 Business Licenses (new and renewals) are due by the 10th of January.

A sticker with the year of renewal is sent out to paid businesses to affix to the business license.

After five years a new license is sent to replace the old one. Please let us know if you need a replacement.

Ordinance 507-2010 is the City's current ordinance on business licenses.

This ordinance can be read in its entirety on the city's website, www.wendell.id.gov

City Ordinance 507-210, section 4: Business License Application

A general license application shall be provided by the City Clerk and the application shall contain information including, but not limited to, the name, residence address and residence phone number of the owner and manager of the business, the street and mailing address of the place of business, the business phone number, and the nature of the business to be conducted at such address and any other information deemed necessary by the City of the health and safety of emergency service personnel or utility service providers. Every application shall be personally signed by the owner or his agent and shall be submitted to the City Clerk within ten (10) days of opening the business or any change in the business as directed in Section 7 of this ordinance. Irrespective of the date of the application, the initial application shall be valid from the date of approval of the license until the end of the calendar year. A general license application as described above shall be provided to the City Clerk to renew the license of the business each year. Said application shall be submitted to the City Clerk by the tenth (10th) day of January of the current year.
